Cheers to 10 Years Giveaway Official Rules

1. **Organizer:** The Competition is organized by Crystal Bridges Museum of American Art, located at 600 Museum Way, Bentonville, AR 72712 (“Organizer”).
2. **Binding Agreement:** In order to enter the Competition, each entrant (“you”) must agree to these Official Rules. Therefore, please read these Rules carefully prior to entry to ensure that you understand and agree. Submission of an entry in the Competition constitutes agreement to these Rules. These Rules form a binding legal agreement between you and the Organizer with respect to the Competition.
3. **Eligibility:** The Competition is open to residents of the United States who are at least eighteen (18) years of age. Employees of Organizer and its affiliates, as well as their immediate families (spouse, parent, sibling, child, and spouse of any of the foregoing) and those living in their immediate households, whether or not related, are not eligible to enter the Competition or to win a prize. The Competition is subject to all applicable federal, state, and local laws and regulations, and is void where prohibited by law.
4. **Entry Period:** The Competition entry period begins Wednesday, October 6, 2021 at 12 p.m. (noon) and ends on Wednesday, October 27, 2021 at 12 p.m. (noon) (the “Entry Period”). However, the Organizer reserves the right to end the Entry Period after Wednesday, October 13, 2021 in its sole discretion.
5. **How to Enter:** No purchase is necessary to enter. Purchases will not increase odds of winning. One entry is allowed per email address. Entering the Competition more than once with the same email address will not increase odds of winning.
6. **Submission Requirements:** By submitting an entry in the Competition (the “Submission”), you represent, warrant, and agree to the following:
 - Contestants are limited to one valid entry during the Entry Period.
 - You are providing real information, accurate at the time of entry.
 - You have not entered into or become subject to any contract, agreement, or understanding that conflicts with your ability to enter into this legally binding agreement and convey the rights set forth herein.
 - The Organizer accepts no responsibility for lost or delayed submissions.
7. **License Grant:** By making a Submission, you hereby acknowledge that you shall not be entitled to any monetary compensation by the Organizer.

The Winner will be final and is not subject to appeal or additional review. The winner will be notified by Crystal Bridges via phone and email that they have won, and the Organizer will use the full name and email entered in the submission as the means of notifying the winner. The full name submitted by the winner may be announced publicly on the Organizer's channels, including, but not limited to, press, social media, email, and web communications, without further compensation to the winner.

9. Prizes: Two (2) night stay (Friday, November 12 and Saturday, November 13) in one (1) room at 21c Museum Hotel Bentonville, accommodating a maximum of four (4) people (cash value of \$560); One (1) 21c Museum Hotel ceramic green penguin (cash value of \$34); Two (2) adult tickets and two (2) youth tickets to North Forest Lights at Crystal Bridges (cash value of \$64); Two (2) adult tickets to the exhibition *In American Waters* at Crystal Bridges (cash value of \$24); One (1) Crystal Bridges T-shirt [cash value of \$9.02 (S-XL), \$11.22 (2XL), or \$12.32 (3XL)]; One (1) Crystal Bridges Mug (cash value of \$6.49); One (1) Crystal Bridges Ornament (cash value of \$9.35); One (1) Momentary Trucker Hat (cash value of \$34); One (1) Momentary Tote Bag (cash value of \$12.95); One (1) Momentary Picnic Blanket (cash value of \$25).
